Purpose

This privacy policy sets out how Platform Resourcing Limited (company number 10707274) uses and protects any information that you provide when using our website www.platformresourcing.co.uk or any of our products and services.

Platform Resourcing Limited is committed to protecting your personal information in accordance with the Data Protection Act 1998 and the forthcoming EU General Data Protection Regulation (GDPR).

What we collect

Platform Resourcing Limited may collect your personal and sensitive personal data such as your name, address, date of birth, contact details, e-mail address and sensitive personal information obtained from your CV such as criminal convictions and ethnic origin.

We may also release your personal information to regulatory or law enforcement agencies, if they
require us to do so by law.

What we will not use your information for:

We understand that personal data breaches are uncommon, however to reduce such breaches we will not share your information with any third-party organisations outside of the specified list below.

To third parties where we have retained them to provide services that we, you or our client have
requested including references, qualifications and criminal references checking services (as required),
verification of the details you have provided from third party sources, psychometric evaluations or
skills test. These third parties comply with similar undertakings of privacy and confidentiality as
Platform Resourcing Limited.

Information in relation to your work history, education history, qualifications and skill set along with your name, location (town) and current job title will be used when being submitted for certain vacancies. This is an essential part of the shortlisting process, and without such information your suitability can not been verified; however name, location and current job title can be removed on the request of you the candidate.

How long do we keep your information for?

We will only retain your data for as long as there is either a statutory requirement for us to do so or to be able to provide a service to you. This will usually require us to retain your personal data after any business relationship has ended for accounts and records purposes and to deal with any account support questions.
